For each variation presented in this document there is a list of the document modes and browser versions that exhibit the behavior described by the variation. All combinations of modes and versions that are not listed conform to the specification. For example, the following list for a variation indicates that the variation exists in three document modes in all browser versions that support these modes:

Quirks Mode, IE7 Mode, and IE8 Mode (All Versions)

Note: "Standards Mode" in Windows Internet Explorer 7 and "IE7 Mode" in Internet Explorer 8 refer to the same document mode. "IE7 Mode" is the preferred way of referring to this document mode across all versions of the browser.

1.4 Standards Support Requirements

To conform to [\[SelectorsAPILevel1\]](#) a user agent must implement all required portions of the specification. Any optional portions that have been implemented must also be implemented as described by the specification. Normative language is usually used to define both required and optional portions. (For more information, see [\[RFC2119\]](#).)

1.5 Notation

The following notations are used in this document to differentiate between notes of clarification, variation from the specification, and extension points.

| Notation | Explanation |
|----------|--|
| C#### | Identifies a clarification of ambiguity in the target specification. This includes imprecise statements, omitted information, discrepancies, and errata. This does not include data formatting clarifications. |
| V#### | Identifies an intended point of variability in the target specification such as the use of MAY, SHOULD, or RECOMMENDED. (See [RFC2119] .) This does not include extensibility points. |
| E#### | Identifies extensibility points (such as optional implementation-specific data) in the target specification, which can impair interoperability. |

2.1.1 [\[SelectorsAPILevel1\]](#) 6.5. Resolving Namespaces

V0001:

The specification states:

```
If the group of selectors include namespace prefixes that need to be resolved, the implementation must raise a SYNTAX_ERR exception ([DOM-LEVEL-3-CORE], section 1.4).
```

IE8 Mode (All Versions)

An "invalid argument" exception is thrown.

IE9 Mode, IE10 Mode, IE11 Mode, and EdgeHTML Mode (All Versions)

A "namespace error" exception is thrown.

V0002:

The specification states:

```
A namespace prefix needs to be resolved if the namespace component is neither empty (e.g. |div), representing the null namespace, or an asterisk (e.g. *|div), representing any namespace. Since the asterisk or empty namespace prefix do not need to be resolved, implementations that support the namespace syntax in Selectors must support these.
```

IE8 Mode (All Versions)

A "namespace error" error is thrown.

There are no additional considerations for error handling.
